Now their associated organization, ECOVIN, is broadening its engagement beyond local vineyards to help support us with our exciting new Wildcats Project in the Rhineland-Palatinate region.

We Thank You! Quilting for Lakes



Happy Trails For Wildcats in the Wine Region

At first glance, wildcats and vineyards do not seem to have much in common. So why winemakers in the Nahe region have taken an interest in protecting them is an intriguing story. Because of intensive hunting, the wildcat population had been nearly decimated in Europe 150 years ago. Since then, wildcats have been making a slow comeback in the few remaining natural forests of Thuringia and the Rhineland-Palatinate. For migratory purposes and to help isolated populations come together to increase genetic exchange, these shy animals need secure corridors to travel. However, in an intensively used and increasingly fragmented landscape, there are more and more barriers in their way, and many fall victim to car traffic in the night. The destruction of the few migratory corridors they have left is therefore fatal for wildcats.

Organic winemakers have been looking beyond the borders of their own operations and taking on additional social responsibilities. In the Nahe wine region, the shy wildcats have been benefiting from these activities and projects. Winemakers from Ruemmelshheim have been actively supporting a citizen's initiative to prevent the deforestation of the Buedesheim Wood. This natural habitat could fall victim to rock mining as many others have in the past. The ancient wood in Buedesheim is the home to some

of the few remaining chequer trees and service trees that grow in the wild. However, these will be completely destroyed and replaced by a lifeless gravel pit if rock mining is allowed. This would be tragic for such an ecologically healthy habitat that is also the place of refuge for 70 species of birds, including the elegant Eurasian sparrowhawk. The forest is also part of a Germany-wide wildlife corridor and happens to be the home for wildcats. It is here that the common interests of winemakers and wildcats intersect. "If the forest is destroyed," explains local winemaker Georg Forster, "cold air from the Hunsrueck mountains will flow uninhibited into the vineyards where Pinot Noir is cultivated. The current microclimate would change, making the soils dryer. This would degenerate the quality of the wine."

Hence winemaking and wildcats find companionship. The preservation of wildcat habitat in the wine region can therefore lead to healthy microclimates that are good for biodiversity and good for wine. *(mu,ts)*

Nature as the Basis for Business Innovative Incentives for More Biodiversity

Healthy ecosystems and biodiversity are fundamental components to human existence. Not only do they make our lives possible but they are also valuable economic resources. Ironically, considering their large economic value, a disproportionately small amount of financial support is given to biodiversity preservation. During the 2012 Convention on Biological Diversity Conference held in India, experts presented their estimate that a yearly sum of between 150 and 440 billion US dollars would be required to maintain global ecosystems in their current condition. In reality, the international community as a whole only provides 52 billion US dollars annually for this purpose. Because many ecosystems (such as forests and aquatic areas) are already so damaged, resources for ecosystem rehabilitation would be required in addition to those allocated for preservation.

Economic instruments or so-called "natural capital markets" are considered to have the potential to close this financial gap by drawing upon the private sector. The Global Nature Fund (GNF) and the Deutsche Umwelthilfe (DUH) examined two such natural capital market instru-

ments: biodiversity offsets and payments for ecosystem services.

Biodiversity offsets are designed around legally prescribed measures for counteracting negative impacts to or replacing damaged habitats. In contrast to biodiversity offsets, payments for ecosystem services are based on the principle of voluntary regulation. The idea behind this mechanism is that those who profit from the use of ecosystems will make contractual payments in the amount necessary for locals to maintain the ecosystem in a healthy condition.

This study by the GNF and DUH helps spread awareness about how these financial instruments are implemented while providing insight into the limitations of each approach. *(th)*

14th Living Lakes Conference Nanchang, China

Achieving the optimal use and protection of water resources gains primary importance in light of the growing world population. Economic considerations also make it necessary to place the protection of lakes and aquatic zones on the forefront. Aquatic ecosystems are the source of life for people, providing them with fresh water, food, and recreation, which makes a decisive impact on our quality

of life. Increasing urbanization is one of the biggest threats for lakes and aquatic zones. Not surprisingly, infrastructure in expanding cities is also becoming more and more dependent upon these sensitive ecosystems remaining intact.

The 14th International Living Lakes Conference is therefore setting the agenda around "Lakes in Densely Populated Re-

gions: Balance between People and Nature". The Jiangxi Provincial Government, the Global Nature Fund, Ramsar, the Jiangxi Department of Science & Technology, the Jiangxi Academy of Sciences, Mountain River Lake Sustainable Development (MRLSD), and MRLDO invite you to join them in Nanchang, China, from November 20th to 23rd. This conference will provide a forum for scientists, water conservation experts, local/regional representatives, and political decision makers, including the Jiangxi Provincial President. The conference's multi-disciplinary composition further develops the portfolio of experiences and outstanding examples, setting the stage for the development of the complex solutions required to address the diverse interests involved in water resource management. *(mv)*




